Public Disclosure of Prudential Information in accordance with APRA Prudential Standard APS 330

This report has been prepared by the Traditional Credit Union (the "Credit Union") to meet its disclosure requirements under the Australian Prudential Regulatory Authority ("APRA") Australian Prudential Standard ("APS") 330 Capital Adequacy: Public disclosure of Prudential Information.

APRA is the prudential regulator of the Australian financial services industry. The fundamental role of APRA is to ensure the stability of the financial industry, primarily through the establishment and enforcement of prudential standards

Under APS 330, the Credit Union is required to disclose information about its capital and risk exposure. These disclosures display the assets of Credit Union, their appropriate risk weighing and the capital base. Capital Adequacy is calculated as total regulatory capital base divided by risk weighted assets.
